Say good bye to KYC documents in future.

Your KYC details are uploaded within 10 days of opening the account to CKYC Records Registry and a unique CKYC Number is generated.

Seek your CKYC Number from entities (regulated by RBI/IRDA/SEBI/PFRDA) like Bank/FI/Mutual Fund/Insurance Company/PoP.* (*For accounts opened on or after 15th July 2016 & for accounts prior to that at the time of renewing KYC).

You can then quote CKYC number as proof of KYC. No need to carry KYC documents again.

Do not share your CKYC number details other than to Bank/FI/Mutual Fund/Insurance Company.
